There is a limited amount of work. It is difficult to keep everyone busy already. There is loyalty of the contractor to consider and their investments into equipment and sustainability for employees. It is important not to get spread work out amongst many contractors so that survival is hard for any contractor.

Even if someone buys a piece of equipment VCF can't ensure employment because they are 'local'.

VC-Explains that the Village of Valemount does a contract every five years and VARDA tendering every year and feels it should be looked at.

Gordon talks about the consideration of a contract for a period of time.

VC- East side anyone can bid on it (construction for BCTS) why not the West side too? You can keep tendering local.

Discussion: Everyone agrees that people should have an opportunity and it should be a fair process. However since there isn't a 'policy' specific to contractor hiring it may appear that hiring is not transparent.

Note: The VCF though it has gone through and expansion but the AAC has dropped. Finding a niche where there is work is, is tricky.

Ainslie thanks Vincent for coming and ensures that the VCF Board will continue to assess a transparent contract process.
