e) Robson Valley Community Services (funding request)

a) Investments-Roads & silviculture- The articles of incorporation didn't allow for this kind of investment under the VCFLP and does under the VCF Co. Ltd.

Discussion: The investment difference could be significant 6 to 10% return. This money is specific to the Silviculture Accrual (legal and binding government obligations) and VCF road and economic stability.

Discussion: The BC Government Woodstove Exchange Program is one option for the Village of Valemount to offer the community. The Village waives the inspector's fees and permits as part of their contribution and have requested the VCF to match the Village of Valemount portion for 10 stoves from each of the \$500.00- and \$1000.00-dollar exchanges.

Though there may be some particulate reduction by replacing old woodstoves; the VCF continues to focus on alternate long-term heating sources for the Village of Valemount with VCF and Valemount Industrial Park initiatives.
