Discussion Highlights:

Use local expertise and include the local fire base

Recommended by BC Government

Protects existing plantations

Planning at SITE PLAN stage so contractors can fulfill certain fire guarding steps before leaving the block and may include the Fire Base for the same such as 'black lining down'

Is there a good template that can be followed?

Debris piled in certain areas to 'pull' the fire.

BCTS burns their blocks or sometimes the logging contractor Big companies tend NOT to burn because the liability is too great Ray Mikolash will talk to BCTS (Clint)at Clearwater to clarify the steps they use to put a burn plan together.

Post-Harvest risk assessment on a Cedar Block would never pass.

Consider cost differences using Broad cast Burning versus Piling and burning. Benefit versus consequences

Craig is concerned about liability if the liability can be removed then the VCF would do BB but burning is NOT a cheaper alternative but another 'tool in the tool box'
