5. Presentation:

a) Ski Delegation-Sherri Malone, Silvio Gislimberti (VV)

The ski society is working with Valemount Glacier Destination to operate the ski hill under their agreement.

The Village is applying for about \$1million grant to purchase and install a 32M span 'forestry bridge' across the McLennan River. This bridge location is outside of the VCF area, it is within Mike Widell's woodlot W0276.

Discussion and questions from a VCF perspective:

Does it make sense to locate a bridge at that spot and does it make sense to own a bridge now for future use? It is good to have a bridge, but the install location is tricky with a steep slope that requires 'rip rap' and the south side is rock. A forestry bridge is better than an 'Ice bridge' as was in the ski society original discussion.

In most cases the VCF would have minimal use of this bridge for harvesting purposes as the Westridge road is developed, the VCF prefers to continue use the Westridge FSR. The VCF could possibly assist with logging to assist in development of the ski hill and to open up the road access to the tow bar lift area.

The MOU between VCF and the VGD has expired.

Grant submission is on October 20, 2020

The Ski Society is requesting a letter of support.

For the VCF to consider owning the asset and carrying the liability of the bridge. This is a question for the VCF Board to answer.

Earlier Joe Nusse and John McGuire did a field site visit.

Joe Nusse has suggested that all geo technical and environmental studies have been done as well the PG District Manager and Mike Widell have worked things through.

Liability and bridge maintenance.

Conflict with industrial access and recreation.

Concern for a working forest getting cut up for recreation.

Advocate and educate; that recreation and working forests can work together over the same area, the landscape does change but trees are a renewable resource.

State in new agreement with VGD that the VCF will be logging.

Does VCF want to own the bridge? The VCF may take the bridge after the village and ski society are finished with it.

For the application who will own the asset? The VCF is not comfortable with owning the asset or being on the hook for maintenance at this time. What is the benefit to VCF of owning the bridge? To protect the Village or other from liability.
