Further thoughts on the impact of Covid 19 to many organizations, lack of community events such as the Community BarBQ, and VCF grant money that has not been spent to date. The pressure that may have increased on organizations that offer social support.

- a) Royal Canadian Legion Branch #266- in their letter ask for support to assist with paying Village of Valemount taxes. It was decided that to pay taxes (or portions of taxes) for any organization is not in the VCF mandate. It could be a slippery slope as other organizations also need to meet their financial goals which include taxes.
- b) Valemount Community Bus Society-At this time the VCF donates annually to operations. The Board was informed that after 10 years of age the bus needs an annual inspection. This time frame is awkward with little lead time as it is so close to the end of the month. Could the Valemount Community Bus Society get an extension of their CBT grant?
