It is the Prime contractor who is responsible for the actions of the sub-contractors. The Board discusses specifically the Harvest Contract; that within the document it should clarify the use of the 5% 'holdback' held from each block and clarify the financial penalty to be incurred for EMS, SP, road violations and other potential infractions. The VCF is responsible to report to the C&E and the District Manager to reconcile any violation(s).
