meeting included Susan Mulkey (Manager of Communications and Extension) from BC Community Forest Association as facilitator. This JWG was to address communication and the determination of this Council to go back to the Board make-up of the earlier Valemount Community Forest model.

(The previous Council followed the recommendation with KPMG and Lawyers to protect the Village from liability and taxes.)

This Council wants to assign two Councilors on the Board and the CAO wants to be an observer and amend the Limited Partnership Agreement.

The VCF/VIP Board of Directors already is losing two successful business people.

9. New Business:

a) Ski Hill- re: VARDA has offered their Crystal Ridge Bridge that had crossed the Canoe River to the Ski Hill Society. Discussion R155-08-21 Motion: The Board is not supportive of an ice bridge due to safety issues, changing weather trends and liabilities. The Board is supportive of the Ski Hill Society to use the VARDA bridge.

- b) Commercial Thinning-Contractor Freya went up the A Road to view the older stands from the 1970's. It looks good for commercial thinning and once done would provide long term benefits such as an increase to the AAC. Consider trial area. (5,000 to 10,000m3/year). Logging Contract-contractor evaluation minimum once per year to include all signed off blocks. Information stays with contractor profile and is a measurement of success.
- c) Logging contracts: discussion re: holdback
- d) Fire-in consideration of extreme wildfire risks; review of implementing broadcast burning methods by doing 'guarding' and/ creation of fire breaks in certain valleys of the community forest to mitigate complete burns. (as what happened in Hugh Allen drainage)

Options of Silviculture treatments vs fire breaks. Low risk vs No risk; there is always risk. Discussion carried forward to next meeting.

- e) Swift Ck Slide-Craig went with the Geotech from Kamloops (hired by the village) to review and assist with the survey.

 Determination: Water did NOT set off the slide. There is a fault line where new and old rock meet at the top of the slide area with evidence of recent movement. The slide will keep sluffing.
- f) Sisco Institute for 3 community forests Sept 22 &23 discussion to attend in Barriere.
- g) National Forest Week- September 19-25-education component/ideas Reach out to VSS and Principal D Shaw to consider tour that profiles job opportunity.
- h) AAC update control statement for MOF K5Q is right on target with 188,500m3 cut out of 189000m3 allowable cut.
 K2T has +/-70,000m3 left in the current 5-year cut control ending Dec.31 2022.
 - This is a good measurement of success and reflects well on the VCF.
- i) Firewood- two loads donated for use by community volunteer groups for those in need.
 - Discussion regarding liability for firewood getters. Create employment to hit targets and clean the bush.
 - Woody debris on the ground; the MOF is NOT dealing with it.
 - For ex. In the Yukon they give fixed area for people to get fire wood.
- j) BBQ-BoD for volunteer appreciation
