### 9. New Business:

a) Winter Harvest Program update-economics and challenges
It is not a great Winter. There is a lack of trucks, poor weather continues to
be a challenge. Hauling into the VCF yard when it should go direct to market.
Pulp is coming into the yard. Lost three trucks in the past year. Long hauls
can move 5 to 7 loads direct, at the end of a week 10 loads are sitting on a
landing. They can't do a legal rounder because of the driving rules.
Hauling more to the yard means loader costs are also up. Fuel rates are the highest
they've ever been.

The short-term goal is to make sure logs get out of the bush and moving contractors for the remainder of the winter to closer areas will offer shorter haul times.

- b) Public meeting-in the near future to have an open meeting with the public. In the interim, prepare the newsletter. Covid has created a challenge to open dialogue at many levels and attendance to public meetings are further compromised to technology and other changing barriers. The annual audit has begun and the AGM will be planned for the completion of the Financials.
