 - a) Dock at Little Cranberry Lake: Update from Ainslie: After speaking with Regional District of Fraser-Fort George, she was advised that a MOU would be approximately a year away. She spoke with Mayor Owen Torgerson who is also on the Board of the Regional District and he supports the idea of the dock. If we are to go ahead with ordering the dock and we are not able to go get an MOU with Regional District the Valemount Marina Association would be interested in the dock.
 - **R224-11-22 Motion:** To approve the purchase of a dock from Triton Docks of Scotch Creek by the Valemount Community Forest. Moved by: **Unanimous**

Ainslie will order the dock and contact VCF contractors to see they would like to make a donation in return of recognition possibly as sign.

- 8. <u>New Business</u>:
 - a) Broadcast Burning Ray: Last week Ray went out with Ainslie, Alana, Darin and David to three blocks. It looks like a nice spring burn. There is easy access and can

be used as a training program for fire base and levitate liability. VCF will need to hire a crew for mop up. Waste assessments will need to be done on these blocks.

- b) Goals Craig: Every 6 months we will review and amend the VCF Goals if needed.
 - i. *Improve communication with Village and the Public:* we now have new board members from the Village of Valemount, we had a big newspaper article on the VCF, the VIP and the VIP sawmill.
 - ii. *Regular Meetings with Trappers, Guide Outfitters and range tenure holders:* Alana wrote a letter and sent a map highlighting their specific areas to all. She heard back from three trappers and they were very pleased.
 - iii. *Road Inventory and database*: Ongoing, Tannis has taken on this project.
 - Examine road permit liabilities, compliance with road construction standards, iv. *Road Use Agreements required:* what are our liabilities? More signage.
 - Realignment of OGMAS: Craig will talk about later on in meeting. v.
 - *Fuel management plans, prescribed burning opportunities:* ongoing vi.
 - *Expand Forestry Week to Elementary School:* we want to do something with vii. both the elementary and high school. Tannis to contact the schools in June to plan for September.
 - viii. *Fine-tune the new form of annual budget review twice a year:* Budget for next meeting.
- c) Waste assessments- The government has a new system for waste assessments, it is costly and slows down progress. The Chief Forester and the Deputy Forest Minister were at the conference in Nakusp said that the goal is to obtain data to try to make a table that can be followed using a district average.
- d) Old Growth Deferrals Craig We may need to go to one of these old growth blocks. 42 km or 6 km. The Board suggests Craig sends an email with their support.
- e) Tab Stumpage All Community Forest and Woodlots have tab stumpage. The First Nations are area based and get a discount. There is no tab stumpage for First Nations. There is a 50/50 possibility that the future will be appraisal or tab stumpage.
- f) C&E Inspection There was an inspection with Adam from Prince George. Infraction – there are no bridge delineators. There were 2 bridges where we received a \$330 fine per bridge. We are in the process of rectifying this.
- g) Incident report Brian was burning 55 kms down the West Canoe. The venting was good but a huge wind came up and fire got into the trees. He received help for equipment that was close. It will have to be reported to BC Forestry and then it will go to C&E.
